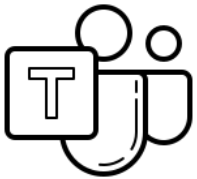

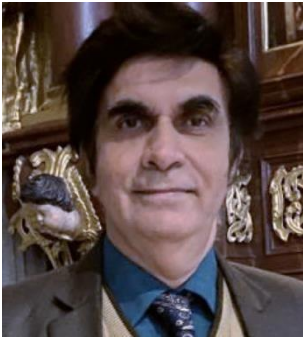

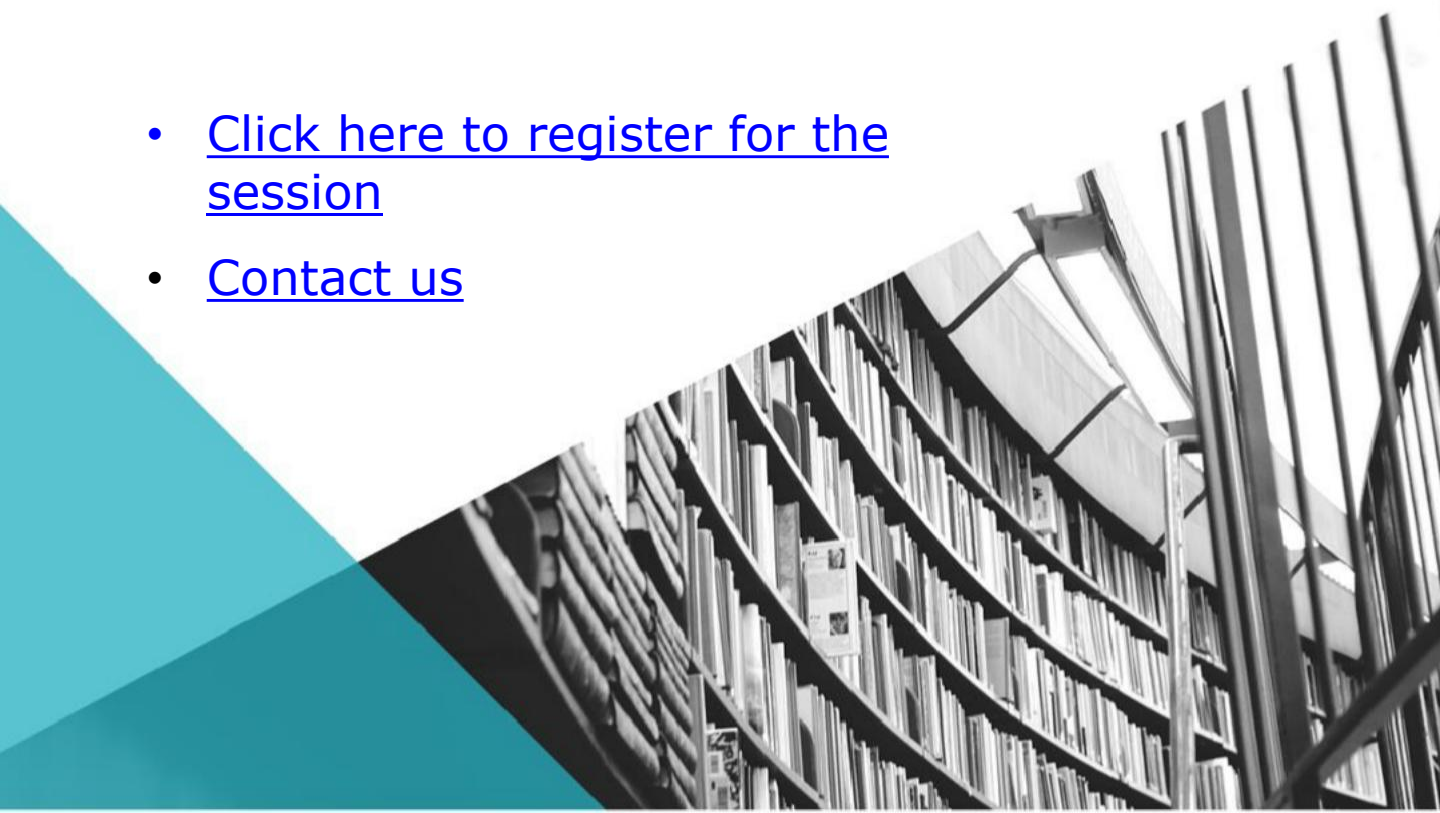

What are the benefits of taking on the PMP® course with an Authorized Training Provider (ATP)?

- All ATPs have to undertake a stringent quality check process, to ensure the course materials, teaching methodology and trainer experience is at par with PMI's® expectations. All course materials provided by ATPs shall also be official PMI PMP® course materials, following the latest syllabus

What are the PMP® exam qualification requirements

- High School Diploma/Degree in any field
- 3 years' project management based work experience if Degree holder. 5 years' project management based work experience if Diploma holder.
- 35 Contact Hours of Project Management education with an Authorized Training Partner®

What is the new PMP® exam format?

- It will consist of 180 questions, with a combination of multiple choice, multiple responses, matching, hotspot and limited fill in the blank.
- You will be provided with 230 minutes to complete the exam

What are the changes within the new PMP® Exam Syllabus?

- The PMP® Certification Exam has changed on 2 January 2021, and will focus on three new domains, namely:
 - People – Emphasizing the skills and activities associated with effectively leading a project team
 - Process – reinforcing the technical aspects of managing a project
 - Business Environment – highlighting the connection between projects and organization strategy
- Content that spans the value delivery spectrum, including predictive, agile and hybrid approaches, will be included across the three exam domains

How much is the PMP® examination fee?

- The PMP® Examination fee is USD 575 (approx. RM 2,700). This fee can also be claimed together with the course fee for HRDF SBL Khas/HRD Corp Claimable Course.

Is there any financial assistance available for payment?

- Yes, the course fee is fully claimable via HRDF SBL Khas/HRD Corp Claimable Course. There is also the option for interest free installment payments, up to 6 months. Contact us for further information.

Do I need to renew my PMP® certification?

- All PMP® certified candidates will have to maintain their PMP® Certification by collecting 60 PMI® PDU points and paying USD 60 to PMI® every 3 years. PDU points can be collected many ways, contact us for more information
